# Modern Love, Modern Laws:

## Civil Marriages and Prenuptial Agreements in the UAE

#### A. Introduction

Since its launch, the Civil Family Court has processed thousands of applications, offering a modern,

streamlined alternative to traditional or religious procedures, with online applications and swift approvals reflecting a forward-thinking approach.
